What You Will Need

- A copy of the Home Energy Rating System (HERS) certificate (please keep the original for your records)
- Your Vectren account number

HOW TO APPLY FOR A REBATE

Step 1: Determine Eligibility

- **Applicant**
The applicant must be a Vectren Energy Delivery of Indiana, Inc. ("Vectren") residential account holder.
- **Application & Certification**
The application must be postmarked within 90 days of HERS certification.
- **Equipment**
Participation must occur between January 1, 2015 and December 31, 2015.

Participants are not eligible for rebates on qualifying equipment through Vectren's Residential Rebate Program.

Rebates are available for single-family homes, duplexes and end-unit townhomes where only one wall is shared.
- **System requirement**
Ground source heat pumps as well as dual-fuel systems, where a heat pump is used in conjunction with a gas furnace, are not eligible for rebates.

Step 2: Complete Application & Attach Certificate

- **Complete Application**
Unless noted otherwise, all fields must be completed on the application to receive a rebate.
- **Sign Application**
The application must be signed in the space provided on page 2 to receive a rebate.
- **Attach HERS Certificate**
Ensure that you have attached a copy of your HERS certificate to the application.

Step 3: Submit Paperwork

- **Double-check Information**
Make sure the information listed on the application is correct and that you have provided all required information.
- **Submit Application**
Submit your completed application and a copy of your HERS certificate within 90 calendar days of certification one of two ways:
