**ThermoShield Program:** Includes all the benefits of the HERS PLUS program AND a comprehensive ThermoSeal air sealing package before wall insulation is installed. This also includes: hot water pipe insulation, foam insulation gaskets, and air sealing plugs for the electrical outlets, as well as air sealing after drywall is installed and customized marketing brochures to help you sell the energy efficiency of your home. This program reduces warranty claims and dramatically improves comfort.
