## HOW TO APPLY FOR A REBATE

### Step 1: Determine Eligibility

- **Applicant**  
The property must be serviced by Vectren Energy Delivery of Indiana, Inc. ("Vectren") under an active residential account.
- New single-family homes, duplexes, and end-unit townhomes where only one wall is shared are eligible for rebates.
- Only one account number can be submitted on an application. For additional account numbers, please complete a separate application.
- Participation must occur between January 1, 2016 and December 31, 2016.
- By requesting a Vectren's Residential New Construction Program rebate, participants are not eligible for rebates on qualifying equipment through Vectren's Residential Rebate Program.
- HERS Certification - The HERS rating must have been completed by a RESNET certified HERS rater. The application must be postmarked within 90 calendar days of HERS certification.


### Step 2: Complete Application & Attach Certificate


- **Complete Application**  
Unless noted otherwise, all fields must be completed on the application to receive a rebate. Incomplete applications will not be processed.
- **Sign Application**  
The application must be signed in the space provided on page 2 of the application receive a rebate.
- **Attach HERS Certificate**  
Ensure that you have attached a copy of the Home Energy Rating System (HERS) certificate to the application.

### Step 3: Submit Paperwork

- **Double-check Information**  
Make sure the information listed on the application is correct and that you have provided all required information and documentation.
- **Submit Application**  
Submit the completed application and a copy of the HERS Certificate within 90 calendar days of certification in one of the following ways:
